

By this petition, the petitioner seeks direction to the respondents to recognise Aalimiyat Examination certificate granted by Darul Uloom Nadwatul Ulema, Lucknow equivalent to H.S.C. (12<sup>th</sup> Standard). The respondent has sent reply stating that the determination of equivalency of standard XII does not come under the jurisdiction of the Maharashtra State Board of Secondary and Higher Secondary Education.
